Prairie Fire Children's Theatre (PFCT) is a professional touring theatre company based in Barrett, Minnesota and has been bringing a theatrical experience to communities across the upper Midwest since 1987. Prairie Fire tours a variety of original adaptations of classic tales.

Throughout the entire year, Prairie Fire Children's Theatre sends two professional Actors/Directors to a community for a one week residency. Local children fill the roles and PFCT provides everything needed to do the show. After a week of rehearsing, the cast will perform the play twice on the weekend. This week-long theater workshop is for ages 7-18 (no exceptions).
